

May Colleague Maintenance

Below are the major problems resolved and enhancements made with this update. The specifics (if applicable) are provided in more detail underneath each issue.

Problems:

Problem resolved: *Co-requisite (CREQ) and prerequisite (PREREQ) issues, which could negatively impact Student Planning.*

Specific issues resolved:

- **TAB key erased data:** Pressing the TAB key on the CREQ form after receiving a specification error erased the data in the Prerequisites field.
- **Pound signs corrupted form:** On the CREQ form, you could enter trailing pound signs (####) in the Prerequisites field, and it corrupted the prerequisite specification.
- **No multi-line editor:** You couldn't use a multi-line editor when entering a prerequisite specification on the CREQ form.
- **No update warning:** Changing the prerequisite specification on the CREQ form did not warn you to update the Print Text that connected to it.
- **Problems registering:** Students weren't able to register for a class, even if they met the prerequisite, if:
 - The student tried to enroll in two classes that were required co-requisites of one another, and also in at least one class with prerequisites that the student had already successfully completed, AND
 - The student selected the PART registration method.
- **Requisite Mismatch problems:** The Requisite Mismatch (RQMM) process was taking a long time to make the initial selection of records to process.

- **Record not found in STRS form:** You closed the whole UI session instead of just the report browser, then logged back in to Colleague to access the Student Terms Summary (STRS) form and received a “Record Not Found” message when you clicked inside the form.
- **Course Section LookUp:** On a Course Section LookUp, the number of available course sections that were closed or waitlisted were not displayed.
- **Student Academic Level issues:** The start date on Student Academic Level didn’t always include of all the student's academic programs.
- **Form switching programs:** When finishing from the Student Profile (SPRO) form, if the student had more than one active academic program, the SPRO form would switch the academic programs on the list.
- **Instructor’s name not printed:** The Registration Statement (RGST) and Student Schedule (SCHD) forms did not print the instructor's name when the instructional method code was more than four characters long.

Problem resolved: *Processing electronic checks in Colleague Finance was not as user friendly as it should have been.*

Specific issues resolved:

- **Status date wrong:** When using the E-Payment Manual Recon (ERMR) process, if the YMD date format was being used, the status date created during the reconciliation process was stored and displayed incorrectly.
- **Wrong error message:** After running the E-Checks Prenotes (ECPN) process, the View Batch Process Status (VBS) report would sometimes display an erroneous error message "X.MSG" instead of the correct error message.
- **Not displaying historical data after deleting address:** When viewing bank account information for a person using the Bank Account Info History (BAIH) form, if the person has current and historical default bank information for one address and that address is deleted using the Person Addresses (ADR) form, the historical default bank information was not being displayed on BAIH if accessed within the same browser session.

Problem resolved: *When you checked out and worked on Colleague Transactions, the custom release package did not include all the required items.*

Problem resolved: *There was an inconsistency with the methods used to determine Nonresident Alien status on federal regulatory reports for IPEDS and NSC.*

Enhancements

Enhancement: *System is now better at accomodating active military and veteran students, and their families.*

New forms and enhancements:

- **Person Military Status (PEMS) form:** Can now track multiple military statuses for each person selected (e.g., an active duty Marine married to a Navy Veteran).
- **Military/Veteran Student Remarks (MVSR) form:** Can now make remarks about military-affiliated students.
- **Military and Veteran Student Parameters (MVSP) form:** Used to define defaults on all the Military and Veteran Student forms.
- **VA Forms Expiration Notification:** Reports when a VA form for a student is about to expire.
- **Veteran Student Information:** Allows for entry of information specific to veteran students.
- **Veteran Student Term Information:** Allows you to record a student's certifications for a term and academic level.

- **Military Student Information:** Allows you to enter information related to military service and benefits for a student who is an active military servicemember or the spouse or dependent of an active military servicemember.
- **SOC Agreement Generation:** A SOC Student Agreement is a degree plan specifically for active duty military and family members.
- **Edit SOC Agreement Template:** Allows administrators to edit SOC Agreement.
- **Enrollment Activity Report:** Provides student enrollment information for a specified date range.
- **Enrollment Activity Export to Excel:** Allows enrollment activity report to be exported to Excel.
